E. Action Items:

a. Approval of the Events and Activities Policy for Professional Staff—*Executive Director, Cesar Rumayor*

This policy proposes that during non-sponsored events professional staff are not permitted to be a part of, or attend, any campus affinity group event, meeting, social or become a student advisor while on the clock during normal scheduled hours. During ASI & SC sponsored events they are permitted to be a part of these events if it coincides with their duties and roll as an ASI or SC staff member and are given approval beforehand. b. Approval of the \$375 for Student Athletics Title IX Games-- *Director for Athletics, Taylor Pilot*

Board member Taylor Pilot asks for funding for the upcoming soccer and volleyball Title IX games. Taylor proposes that with the funding \$5 food vouchers will be given to the first 25 students for both Men's and Women's Soccer, along with Women's Volleyball.
