**Resolution Requesting Career and Professional Development Center (CPDC)
to Coordinate Multiple Career Industry Fairs that Focus on the Specific
Needs of the Students within the Four Academic Colleges at Stanislaus State**

1. **WHEREAS:** The Associated Students, Inc., (ASI) is the representative body and the official voice of the students at California State University, Stanislaus; and
2. **WHEREAS:** ASI acknowledges and values the mission of the Career & Professional Center “Career Services also serves as a resource for employers seeking to recruit well educated graduates to fill the Central Valley region’s employment needs”; and
3. **WHEREAS:** Students would be motivated and more likely to attend a career fair that is tailored to their specific career interests, that offers resources designed with their individual colleges in mind; and
4. **WHEREAS:** ASI strongly believes students would be best served by offering career industry fairs throughout the academic year providing information and material specifically focused and relevant to each of our four academic colleges, academic departments and/or industry such as:
 - Professional & Business Services
 - Communication, Creative Arts & Media
 - Education & Training
 - Government & Public Services/Administration
 - Health & Wellness
 - Energy & Technology
 - Agriculture and Manufacturing
 - Law, Public Safety, Corrections, & Security
5. **WHEREAS:** Coordinating industry career fairs (similar to the College of Business’ *Meet the Firms* format) would allow academic colleges and departments to market to their own students, thereby encouraging increased student attendance, and being an added incentive for employer participation.

6. **RESOLVED:** To strongly recommend the Career and Professional Development Center actively seek student and faculty input specifically from each academic college and department to attract high attendance and be continuously beneficial; and
7. **RESOLVED:** That separate career industry fairs be offered with each fair coordinated specifically with the goals and career paths of the students within these academic colleges and departments at the forefront.
