**Resolution on Extending Hours of Campus Departments, Services
and Programs**

- 1. WHEREAS:** The Associated Students, Inc., is the representative body and the official voice of the students at California State University, Stanislaus; and
- 2. WHEREAS:** Many students have full-time employment and/or other obligations that prohibit them from attending classes during the day, requiring evening-only attendance, including (but not limited to) graduate students and students in our credential programs, etc.; and,
- 3. WHEREAS:** Many campus offices, programs and services maintain operating hours that make them unavailable to students who can only be on campus during the late afternoon and/or evening hours; and
- 4. WHEREAS:** Campus services, programs and offices that close/end by late afternoon are doing a disservice and putting at a disadvantage those students who can only be on campus during evening hours; and
- 5. WHEREAS:** We feel it imperative that *all* our students have access to all campus offices, programs and services, whether they attend day or evening classes, and therefore recommend and request the following offices extend their hours on Mondays and Wednesdays, closing at 6:00 pm:
 - Academic Success Center
 - Financial Aid/Financial Aid appointments
 - Cashier's (including in-person assistance)
 - Learning Commons
 - Library (specifically Reference Desk Chat)
 - Writing Center
 - Health Center (specifically for patient care and pharmacy)
 - Psychological Counseling Services
 - Disability Resource Services

- Warrior Food Pantry
- Cal Fresh
- University Police Department
- Enrollment Services

6. WHEREAS: We additionally recommend and request the following events, workshops, etc., accommodate students who cannot be on campus during typical daytime business hours, by offering evening hours:

- Food distribution events
- Career and Professional Development Center workshops and office hours
- Library Research Assistant be available during certain evening hours
- Financial Aid workshops

7. RESOLVED: It is imperative to the success and well-being of our students that *all* have access to everything our campus has to offer, whether or not they can access our campus during typical daytime business hours; and,

8. REQUEST: That our campus offices, departments and services adopt extended hours as outlined above to make their services available to all students attending our university.
