

## ASSOCIATED STUDENTS INCORPORATED OF CALIFORNIA STATE UNIVERSITY, STANISLAUS

Resolution Supporting International Students During July 6th, 2020 ICE Directives

1.	WHEREAS:	Associated Students, Inc. is a part of the California State University (CSU)
		system which is over 487,000 students in the California State University (CSU),
		including the 16,122 international students within the CSU, 24 being enrolled at
		Stanislaus State in the Spring of 2020; and

- **2.** WHEREAS: The mission of Associated Students, Inc., is to be a representative body and the official voice of the students at California State University, Stanislaus; and
- **3.** WHEREAS: International students and their right to an equitable education through California State University is just as important as any and all other CSU students; and
- **4.** WHEREAS: CSU Chancellor Timothy P. White announced on May 12<sup>th</sup>, 2020 that all 23 CSU campuses will be offering courses in the Fall 2020 semester primarily in a virtual instructional format; and
- 5. WHEREAS: The US Department of Homeland Security (DHS) and the Immigration and Customs Enforcement (ICE) agency released modifications on July 6th, 2020, regarding the Student and Exchange Visitor Program (SEVP) exemptions for nonimmigrant students taking online classes for the Fall 2020 semester, and plans to publish the procedures and responsibilities in the Federal Register as a Temporary Final Rule; and
- 6. WHEREAS: These modifications stated that nonimmigrant F-1 and M-1 students attending schools operating entirely online, will not be allowed to take a fully online course load and remain living in the United States, as the US Department of State will refuse to issue visas to students enrolled in these fully online schools; and
- 7. WHEREAS: The admission application deadline for other universities has passed and CSU students would not have had an opportunity to transfer to other universities in compliance with ICE directives; and

**8.** WHEREAS: The CSU Graduation Initiative 2025 aims "to increase graduation rates" while

"eliminating opportunity and achievement gaps" for students, yet the

modifications released by ICE would have detracted from the students ability to

access available resources due to limitations; and

**9.** WHEREAS: According to the Pew Research Center, "Most countries in the world have

imposed partial or complete border closures to foreign nationals due to

Coronavirus outbreak" meaning current traveling restrictions would have caused

undue harm and difficulty to students' ability to travel; and

**10.** WHEREAS According to the Center for Disease Control and Prevention (CDC), "Some

healthcare systems are overwhelmed and there may be limited access to adequate medical care in affected areas. If you choose to travel internationally, your travel plans may be disrupted, and you may have to remain outside the United States

for an indefinite length of time," and

11. WHEREAS: The forceful journey during this current pandemic would have caused undue

stress and damage to the mental and physical health of students, financial burden,

and hinder students' academic progress; and

12. WHEREAS: Mandating students to return to their home country may limit access to resources

such as the internet, timely access to online classes due to time zone differences,

or specific resources needed for success in online courses; and

**13.** WHEREAS: Students may not be able to attend classes in their home countries due to

censorship, lack of access to technology, or hostility that endangers their well-

being and safety when studying subjects sensitive to their home countries; and

**14.** WHEREAS: Additionally, international students have an already invested livelihood in

California through paid leases, drivers' licenses, and prepaid insurance, etc; and

**15.** WHEREAS: International students pay fees for on campus services such as; Materials,

Services, and Facilities Fee, Health Services Fee & Health Facilities Fee, Instructionally Related Activities Fee, and under the directives previously released by the Department of Homeland Security, access to such resources

would be hindered and inaccessible; and

**16.** WHEREAS According to researchers at EducationData.org, in 2019 international students

contributed \$6.8 billion to the California economy, 53% on higher education,

19% on accommodation, 12% on dining, and 10% on retail; and

17. WHEREAS International students studying at US colleges and universities contributed \$41

billion to the economy during the 2018-2019 academic year; and

**18.** WHEREAS: As student leaders, we recognize that during these unprecedented times, the

health, safety, and education of our 16,122 international students should not be

jeopardized as a result of the current political climate.

Although the previously mentioned July 6<sup>th</sup>, 2020 ICE directives were rescinded 19. RESOLVED

on July 14th, 2020, Associated Students Inc. demands that similar directives not be put in place to put the lives of international students in danger; and it be

20. RESOLVED: Associated Students Inc. demands the Chancellor's Office to use the CSU's

> legal resources to determine the legal flexibility we have in supporting our international students in preventing any forceful removals from the United States if ICE reimposes similar guidelines to those released on July 6th, 2020; and be it

21. RESOLVED: Associated Students Inc. calls upon the Chancellor's office to use the CSU's legal

resources to ensure that CPT and OPT employment programs for F-1 students

can continue unhindered by future ICE guidelines; and be it further

22. RESOLVED: Associated Students Inc. stands with our international students throughout this

situation, and we pledge our advocacy to them; and it be further

**23.** RESOLVED: That this resolution shall be distributed to CSU Chancellor Timothy P. White,
