Resolution and Recommendations Concerning Campus Food Services

1. WHEREAS: The Associated Students, Inc., is the representative body and the official voice of the students at California State University, Stanislaus; and

2. WHEREAS: Board members of the Associated Students, Inc., Board of Directors, have received various concerns regarding the current food services on campus; and

3. WHEREAS: In addressing the continual concerns and suggestions voiced by students, we believe there are several areas where improvements can be made; and

4. WHEREAS: To address the specific concerns, we recommend improvements can be made in the following areas:

COMMUNICATION

- Require Warrior Eats to better communicate and advertise updates to the campus community, to include:
 - ✓ Communicate all food vendor options and operating hours (via website, social media, email, etc.)
 - ✓ Provide updates on the plans for Main Dining

BOOST APP

• To increase efficiency, address technical issues as soon as they arise in a prompt manner

MAIN DINING

- Ensure this area has "grab and go" food options for students (so students are not forced to stay in Main Dining to eat, especially important when seating space does not accommodate everyone)
- Make known that Main Dining is solely a food vendor location for student dining and *not* an event space (particularly important since Village Café will be closed during Fall 2023).

• Main Dining should be a location where students are confident in knowing they can purchase food on campus

ETHNIC FOOD ON CAMPUS

- Ethnic (culturally based) food should be available for special events on campus
- If Chartwells is unable to provide the specialty food as requested for an event, the student organization or department (etc.) should be allowed to purchase this food from an outside vendor

\$250 LIMIT WHEN PURCHASING FOOD OFF CAMPUS

As a result of the rising food prices caused by inflation, Chartwells has
increased their food prices on campus. As such, this \$250.00 limit when
purchasing food off campus should also be increased accordingly

IMPROVE EFFECTIVENESS OF DINING SERVICE OVERSIGHT COMMITTEE

- Define the structure of this committee
- Determine those people/positions most necessary to be a part of this committee and create a list
- Define the specific charge of this committee
- **5. RECOMMEND**: To improve the overall effectiveness of food services on campus and to address the concerns of students, the above recommendations should be instituted.
