- **a.** Approval of 2020-2021 Budget Formulation Table
 - Teresa states this is a timeline for creating a budget and the budget hearings
 - She states if the board of directors approve then they will move forward with the time line
 - She states the executives and professional staff will work on the budget drafts for 2020-2021
 - She adds that they will meet with the executive director about the budget the week of spring break
 - She states there will be 3 budget hearings
 - She says that her and Karmjit will present for ASI and SC leadership
 - Teresa states that the SC operations and service desk will be presented by Scott

- She states that the 17th will be shared by ASI and SC programming, Jocelyn, and ASI and SC administration by Cesar
- She states that after they will make budget additions or cuts made by the budget committee
- She adds that after that is done they will present the first reading of the proposed 20-21 budget to the directors April 30^{th}
- She says that the budget committee approves the budget for the 20-21 on May 1st
- She states it will be brought back to the board of directors to vote on the proposed budget

b. Approval of SC Custodial Services Supervisor

c. SC Vice Chair of Finance- Teresa Serna

- -She states she is working on a PowerPoint for student organizations that discusses the services the Student Center and ASI provides for the student clubs and organizations so they can become more informed

d. SC Vice Chair- Melannie Castellanos

- -Melannie states that the advertising event for the grand opening celebration, hot chocolate and coffee, had 202 people participate
- She states at the actual celebration there was 931 people
- She adds that judicial and policy committee dates are set
- She says that Michelle is going to chair policy committee
- She states she will send out dates for judicial

e. SC Chair- Jennifer Galeana-Vasquez

- Jennifer states there is now a vacancy for a student director for the Student Center
- She states that if the board knows anyone that is interested to give them her email
- Jennifer states that Mary Stephens is leaving the campus
- She adds there is a new VP of business and finance
- Jennifer states she is working on a flyer that states the services and spaces the Student Center has
- -She says that she will be attending the commencement committee
- She thanks the board for coming to the student center events and being on the committees
- She states the SC has been open for 9 days
- Jennifer states they presented to the university committee of public art
- She states they presented the warrior bronze statue and the Stan State letters
- She states they got great feedback
- -She says they just need to work on the wording for the plaque for both pieces
- She says the committee suggested an alternative location for the letters
- She states they will discuss it in operations then will bring it back to the board
- She states they got them contacts to work on sculptures

f. SC Executive Director- Cesar Rumayor

- Cesar also thanks everyone for coming to events and helping out
- Cesar thanks Katie for all her hard work
- He states at winter retreat board members stated they would like more responsibility
- He says that an idea was a programming aspect for the Student Center committees
- He states they will follow up with an informational piece on organizations as well
- He states they are at 452 bricks sold
- Cesar states the brick space is very large and they are trying to come up with a new design
- He says they are trying to figure out how many bricks they need to sell in order to fill up that space
- Nicolette asked if the brick campaign is getting opened again why does the design have to change
- Cesar states the space is very large so it is needed to change because the design no longer works for the given space
- Cesar states there is a vacancy, the assistant director of programs service assessment took another position in Modesto
- He states there will be a conversation with executives from both ASI and SC on how they are going to move forward
- He adds this was the position they moved to the Stockton campus to start addressing programs and services
- He states they will begin a game plan and discuss it at the next meeting
- Cesar states there are dates for the vendors but they are subject to change
- He states they are shooting for the Market opening on February 19th, Shake Smart and Warrior Grill February 24th, Starbucks, Sushi, and Titus Grown on March 9th
- He says regarding reservations, they are still trying to figure out wiring issues
- He adds that the IT department does not want to start their work until the outside contractors address all their concerns
- He states AV, audio and visual, equipment is there and arriving but it is not yet being installed
- He states they will give an update on Friday on when they will start on AV equipment
- Cesar says that as of right now they will continue to close the building at 6pm since it is still a working site
- He states they are hoping for the week of February 17th that they can keep the Student Center open until midnight for students
- He adds that reservations are pending for conference rooms
- Cesar states that they plan to reach out to disabilities services to do a walk through with accessibilities to identify what needs to be done further
