VI. Action Items

a. Approval of Ricardo Ramirez as the SC Building Maintenance Supervisor

- -Scott states Ricardo Ramirez was their next choice to fill the position
- -He states he was impressed with his leadership skills and training
- -He adds he will be a good fit for the positions
- -Motion to approve by Zoe Martinez, second by Donovan
- -Mariah asked why Ricardo was the second option
- -Scott states their first choice had a more certifications, and training -Motion carries 11-0-0

b. Approval of the ASI & SC Student Assistant 2021 Classification and Pay Rate

-Ammie states for several years they have been working on the classification table for student assistants

- -She states that with minimum wage constantly increasing pay rates have to increase
- -She states that some classifications had to be merged, classification positions 1 and 2 have been merged
- -She states jobs that are assistant positions are now in classification 1 and the pay is recommended to be 14.25 an hour
- -She states classifications that are currently in level 3 are being moved to 2 and the pay is moving from 13.50 to 14.50
- -She states the only positions that will be in level 3 are Student Advisor, Web and App
- -She states level 4 will be graduate students
- -She adds Presidents and Chair positions will be paid the same, at 16 an hour, and Vice chair/presidents will be paid the same at 15 an hour
- -She states this will not be effective until January 1st 2021
- -Motion to approve by Gary Potter, second by Nicolette Padron
- -Motion carries 11-0-0

c. Approval of \$175,000.00 for Renovation and Furniture at the Stockton Campus

- -Jennifer states they plan on adding more tables, chairs, microwaves, refrigerators for the Student Lounge
- -She states she wants it to match the student center, for those students who have been to the Turlock Campus and are going to the Stockton Campus there is a connection
- -She states for one of the walls they want to include a campus pride mural
- -She states the ASI and SC suit will have a front desk where she would like to see merchandise being sold, print and go, passes for busses, and anything else students would like to purchase
- -She states she would like to renovate the middle court yard, they would like to add furniture that matches the Warrior Grill,
- -She adds the renovation will cost roughly 168,000.00, but is requesting 175,000.00 for cushion room
- -Ravinder asked when would the renovations start
- -Jennifer states hopefully in the summer, she needed approval so she could start, but could possibly change because of COVID-19
- -Maria asked who is in charge of cleaning the student lounge and student court yard
- -Jennifer states currently the furniture is not being cleaned, but can be added to duties of workers
- -Donovan asked if the 175,000 would be enough cushion space if things were to go wrong
- -Jennifer states she thinks it will be enough
- -Gary asked if this was the budget from before
- -Jennifer states more renovations have been added to the furniture pricing, they did raise the requesting amount of 30,000 to 55,000 for furniture cost
- -Motion to approve by Mariah, second by Donovan
- -Motion carries 12-0-0
