- -She states there was meetings on how to better serve students of color

b. Approval of the 2020 - 2021 Organizational Priorities

- -Donovan asked how many projects will be possible with the online format

- -Adela asked if the outdoor storage was for students or the organization

b.ASI Representative- Cynella Aghasi

-Cynella states she doesn't have much of a report but would like to congratulate everyone on their first SC Board of Directors meeting

c.ASI Student Government & Leadership Manager- Katie Rotan

d.SC Vice Chair of Finance- Teresa Serna

- -Teresa states she has been working with the Stockton Campus on renovations
- -She states she will be working on SC student organization funding policy
- -She states she will be working with Mariah and Katie for the senior art gallery
- -She states she has been reaching out to Student Organizations to create recruitment videos

e.SC Vice Chair- Mariah Burciaga

- -Mariah states she has been working with Karlos for summer retreat
- -She states she has been working within her COVID related committee, they have been discussing events that will happen either virtually or in person
- -She states she has been working on fall programming with Melannie and Teresa

f.SC Chair- Melannie Castellanos

-Melannie states the executives have their priorities lined up and are working closely with Katie and Cesar

- -She states the contract for the mural has been sent out, they are just waiting on the finalization of paperwork
- -She states she found an artist to create the quilt, and paperwork will begin shortly
- -She states Cynella and herself have been working on a statement for students on why they are still charging student fees
- -She states she has been working on programming for student leadership, and students

g. SC Executive Director- Cesar Rumayor

- -Cesar states he would like to thank the executives who have been working all summer
- -He states the lease agreements will have to be renegotiated, since they do not have access to the building, so they are not wanting to pay rent
- -Alice asked about if the lawsuit is affecting the student organization
- -Cesar states there is a class action lawsuit but will take a few years to have major progress
- -He states since no one knows what will happen, they will continue to move forward and be transparent with students
- -He states they are asking for an extension on spending the money due to COVID-19
- -Cassandra asked what the limitations are on what we spend
- -Cesar states group two has to be spent on equipment and furniture, and construction funding needs to be spent on anything related to construction
- -Dr.Erickson asked what happens to the money if it is not spent by a certain date
- -Cesar states group two will be kept into savings, and the 4 million will be put into a bond that cannot be touched, but the SC debit will go down
- -He states there has been planning on services for students
- -He states one of the services that have been approved is, answering the telephone main line
- He states students have been having frustration with voicemails, and not being able to speak to a real human
- -He states we will be able to answer the phone, from 7:45am-6pm Monday- Thursday and 8am-5pm on Fridays
- -Donovan asked how that will work for departments that have moved services to online
- -Cesar states that is what is being worked on now, to see what departments set ups are
- -He states the other proposal that may or may not happen is using the event center as a computer lab, or study area
- -Adela asked if hot spots will still be available for students
- -Cesar states yes there will be
- -Donovan asked if the event center is going to be used, do students have to pay for parking still or will that be accommodated
- -Cesar states from what he has heard students will have to pay for parking as if they would in person for Fall 2020
- -He states as far as student assistants, the ones that do not have work will be furloughed
- -He states they are still employed with the organization, they just won't have set hours
- -He states it will affect 10 students, because there is no work for them
- He states there were no new students hired this year, and they were all student workers from last semester

IX.Announcements

- -Adela asked if students who get work-study in their student aid will still happen
- -Andy states work- study money has been acknowledged in the funding, and that money should be used for hiring potential students
- -Cassandra asked if hiring will still happen, or are students being hired currently
- -Cesar states every department may be different as far as jobs for students and what their budgeting is
- -Andy states student affairs are working on hiring student assistants
