VI. **Action Items**

a. Approval of \$271,250.00 for the Stockton Campus Renovation and Furniture Projects

-Jennifer states that they want to fund \$30,000 for the Stockton Student Lounge repairs and furniture -She states for the Library Services room they want to fund \$20,000 -She states for the office space, they want to fund \$53,000 for flooring, paint, HVAC, and electrical -She states for hazardous materials testing for the office space they want to fund \$10,000

-She states for contingency they want to fund \$11,300

-She states for Warrior Lounge A equipment and furniture they are asking for \$20,000

-She states for Warrior Lounge B they want to fund \$55,000

-She states for ASI & SC Warrior Activities Center that total will be 20,000 -She states for Campus Pride Courtyard Furniture that total will be \$10,000

-She states for installation cost it will \$15,000

-She states they want to put in a refrigerator in Warrior Lounge A is budgeted for \$2,000, they also want to put in microwaves, and they want to budget \$1,000 for that

-She states they also want to install a display board, they budgeted \$1,500

-She states for contingency they are asking for \$12,450

-She states they budgeted \$10,000 for the campus mural

b.Approval of the revised Lease Agreement for Auxiliary Business Services - Food Vendors

-Melannie states the lease for food service, the monthly rent will be charged 50% off for March 2020, 75% off April- June 2020, and 75% off July 2020- June 2021 -Motion to approve by Donovan, second by Joenna

c.Approval of the revised Lease Agreement for Auxiliary Business Services - Bookstore

-Melannie states the bookstore lease rates was originally \$2.09 per square foot -She states the bookstore is still operating, they want to give them only a 25% discount off their lease rate -Motion to approve by Elizabeth, second by Cynella -Motion carries 15-0-0

d.Approval of the revised Lease Agreement for Student Affairs – Student Leadership & Development
