  - a. University Police Department Chief Clint Strode

- He states that there are 6 students appointed to that committee

- -He states Daily Cleary crime log reports were available for people to look at as well
- -He states these logs are from the campus and from around the area
- -Cesar states that there has been conversation around campus about Law enforcement being more sensitive at cultural events, maybe not wearing uniforms not wearing a gun.
- -He asked if these types of conversations were going to happen at those advisory committees
- -Clint states that yes, that is the main goal for that committee is to have those conversations and to also talk about what else people are saying and address it
