V. Presentation

- a. Stockton Campus Renovation Jennifer Galeana-Vasquez, SC Programs & Services Coordinator
- Jennifer states three rooms were renovated, and the patio as well
- She states in Room 1110, received new paint, new carpet, HVAC, furniture, and storage
- She states they are currently waiting for the merchandise wall to be installed
- She states Room 1024 also known as Warrior Lounge A received, new carpet, new paint, a laptop bar, updated kitchenette, and added lockers and cabinets for more storage
- She states that the furniture has been installed
- Jennifer states for room 1025, also known as Warrior Lounge B, received matching carpets and painting like the other 2 rooms

- She states she is requesting \$12,717.79 for Warrior Lounge A, \$49,554.48 for Warrior Lounge B, \$17,288.16 for ASI and SC Warrior Activities Center, \$7,783.48 for Campus Pride Courtyard Furniture, \$4,305.00 for office furniture 1030, \$10,197.56 for Installation costs, and \$21,953.53 for Contingency.
- She states she is also requesting \$1,200 for Laptop charging cart

b. Approval of the Revised Student Organization Funding Policy

- -Maria states there was only one edit made to this policy that has been approved before

- -She states it's a form of startup funding for organizations
